

Letter of Commitment to Covid-19 Prevention at 2022  
Beijing Media Center  
(February 1 to February 20)

As a journalist working at 2022 Beijing Media Center, I, in the spirit of honesty and trustworthiness, promise to fulfill my personal responsibilities in the quadripartite responsibility mechanism for Covid-19 prevention and control:

I. The co-resident(s) and I meet the following conditions for the past 14 days before I sign on this Letter of Commitment:

A. No history of travel to/residence in medium/high risk areas or communities with reported Covid-19 cases.

B. 1. No history of travel to/residence in/contact with a prefecture-level city (districts and counties within Municipalities directly under the Central Government /sub-provincial cities), where medium/high risk areas are located;

2. No history of travel to/residence in/contact with a prefecture-level city where new local Covid-19 cases are reported;

3. If there is a history of such travel/residence/contact in 1 and 2, my risk of infection has been excluded.

C. No history of contact with confirmed cases, suspected cases, or asymptomatic infected persons within the past 21 days.

D. No contact with patients with an epidemiologic history of fever or respiratory symptoms.

E. No contact with/involvement in disease clusters (2 or more cases of fever or respiratory symptoms in a small confined area, such as home or office, within the past 14 days).

F. I am not a previously confirmed case or asymptomatic case, who has been cured and discharged from the hospital but is still subject to follow-up visits or any medical observation period.

G. No co-resident(s) whose work is associated with imported cargo, or who work at ports of entry or centralized quarantine and isolation facilities.

II. Before entering the Media Center, I have received full vaccination against Covid-19 and proactively provided the vaccination certificate.

III. I shall strictly observe the entry (return) policy formulated by the Joint Prevention and Control Mechanism of Beijing. I shall obtain a report of negative Covid-19 nucleic acid test result generated within 48 hours before entering Beijing,

and take another nucleic acid test within 72 hours after arriving at Beijing. If there should be any changes to the relevant pandemic prevention requirements, I promise to follow them consciously and actively.

IV. I shall obtain a report of negative Covid-19 nucleic acid test result within 48 hours prior to entering the Media Center. During the work period, I will strictly follow the requirements of "2022 Beijing Media Center Pandemic Prevention and Control and Medical Service Plan", take nucleic acid tests arranged by the relevant departments, and ensure a nucleic acid test conducted every 48 hours. If report of such a negative 48-hour nucleic acid test result is unavailable due to my personal reasons, I am not allowed to enter the Media Centre.

V. I shall have no abnormal results of health screening within 14 days prior to entering the Media Center. While working at the Media Center, I will conduct daily self health check and monitoring, including body temperature measured twice a day, one in the morning and the other in the evening. I will also check and monitor any suspected symptoms of infectious diseases, such as fever, cough, fatigue, dizziness, headache, nausea, vomiting, diarrhea, jaundice, rash, conjunctival redness and swelling, and loss of taste and smell. I will scrutinize whether I have any contacts with those with fever or respiratory symptoms. If there is any abnormal health condition, I will immediately report, and seek medical help with effective personal protection equipment. I will resolutely not go to work while being sick.

VI. I shall comply with the regulations of pandemic prevention and take personal protection measures. I shall wear masks properly, ensure hand hygiene, maintain a clean living condition and open windows regularly for ventilation; I shall not spit in public places or take part in mass gatherings. I will keep a regular and healthy schedule of work and rest, maintain psychological health, and ensure sufficient sleeping.

VII. In case of an emergency, I will follow the arrangements of volunteers and staff members at the site, and cooperate with disease control personnel to implement pandemic prevention and control measures.

VIII. I will follow the "Law of the People's Republic of China on the Prevention and Control of Infectious Diseases" and provide the relevant information truthfully for the interest of my own health and the health of other people. I will bear the corresponding legal liabilities caused by inaccurate information.
